Terms and Conditions of the Contract- Catering

1. The contractor will have to make arrangement for cleanliness of Kitchen Area and its surroundings to the satisfaction of the KVs. The contractor shall also be responsible for the safe and hygienic disposal of the waste material.
2. The contractor shall arrange for crockery, utensils, boilers, juice machine, cooking gas cylinders, cooking store etc and items of similar nature of goods quality as approved by the KV at his own cost and maintain the said items in proper and hygienic conditions for due discharge of obligations in respect of running of meets.
3. The contractor will have to provide employees in proper uniforms for service.
4. The contractor will be required to provide service in the premises and also in various rooms of the KV.
5. The contractor shall employ only such persons as are declared medically fit as certified by the Govt. Hospital. No employee will be under the age of 18 years. The documentary evidence will be provided by the contractor.
6. Only cooking gas is to be used in the preparing hot drinks & cooking which is to be arranged by the contractor including gas cylinders.
7. The contractor will be fully responsible for the repair/maintenance, cleanliness, breakage and damage done to the building and sanitary, electrical and any other fittings and fixtures install in the space provided to him by the KVS for the purpose of preparing lunch, tea and coffee. Furniture provided to the contractor will be maintained properly. Any loss/damages (including repairs) to the same will have to be made good by the Contractor at his cost.
8. Material used for cooking purpose standards as fixed by FSSAI.
9. The contractor will take all necessary precautions against fire hazards and comply with rules and regulations as laid down by concerned local authorities and to the satisfaction of the K.V
10. The rate list and menu as approved by the K V should be displayed conspicuously daily.
11. The size and weight including quality of the various items should be approved by the KV. No new items would be introduced without approval of the KV. No rate will be revised without the approval of the KV.
12. The contractor will have to employ the required staff at his own cost and bear all the statutory and other liabilities. The contractor will have to pay the minimum wages as per notifications issued from time to time. EPF and Bonus etc as per Employees Provident Fund Act and Bonus Act amended from time to time.
13. The KVS shall not in any manner be treated as the employer of these employees or concerned with the terms of their employment or conditions of their services since the relationship of employer and employees shall always be considered to be between the contractor will make these conditions clear to them categorically and in writing, and their acceptance of these terms shall be communicated to the KV also.
14. The contractor shall obtain license under the Contractor Labour (Abolition and Regulation) Act 1970 (hereinafter referred as the contractor labour Act) and all other requisite licenses at his own cost from the Appropriate Authorities and comply with the terms and conditions of the license(s) and all other relevant and necessary provisions of the contractor labour Act and the Rules framed there under all such other provisions of laws in any enactment or otherwise laid down by any authority from time to time, it being clearly understood and agreed upon that the entire responsibility for compliance thereof shall always be of the contractor. The contractor shall be fully responsible for any compensation etc. in case of any injury/casualty or mishap to any employees of the Catering during working hours.
15. Under no circumstances any of the contractor's employees will stay in the KV premises beyond working hours after closing the Vidyalaya. He will ensure that the kitchen rooms are properly locked and secured during closed hours of KV. The access to the space allotted to the contractor will be as per the conditions and in the mode as prescribed and regulated by the KV from time to time which will be binding on him and his employees. The KV reserves the right to inspect the premises allotted to the contractor including the store at any time.
16. The contractor shall not entertain any orders, or supply from outside KV.
17. The contract will be for one year to start with from the date of signing the agreement and agreement may be renewed by the KV on such terms and conditions as may mutually be agreed upon between the parties. The KV reserves the right to repudiate the contract at any time after giving one months notice, if the KV is not satisfied with the working of the said contractor. The contractor, if so desires, may seek termination of the contract by giving written notice of not less than three months duration during the agreement period.
18. The contractor will, at all times, ensure discipline decent and courteous behavior by his employees while they remain in premises of KV. In case any of his employees indulges in any act of indiscipline, misbehaviors of slogan shouting or indulges in violent act(s) or abets others in doing so and it is prima facie proved, the contractor shall remove the employee concerned from the premises immediately or receipt of written communication from the authorities which will be duly acknowledged by the contractor.





19. Under exceptional circumstances the KV reserves the right to change any term and condition as and when warranted.
20. In case of any dispute arising out of the interpretation of the terms and conditions of the contract, the decision of the Commissioner, KVS will be final and binding.
21. The contractor will be required to execute an agreement in the prescribed form in this behalf in case the contract is awarded.
22. The contractor will have to deposit **Rs.15,000/-(Rupees Thirty Five Thousand Only)** as performance security in the form of DD, drawn in favour of **KV MRN VVN ACCOUNT**. The same will be refunded without interest when the contract is over and premises are headed over the KV and all dues from the contractor have been settled.
23. The contractor will not further sub-contract the contract to any other party. In case the contractor is found having sub-contracted this contract, the contract will be terminated without any notice and security deposit will be forfeited.
24. Every tender should be accompanied by a **Bank Slip of NEFT/RTGS Rs.5000/-(Rs. Five Thousand Only) as Bid security in favour of " Principal, KV MRN VVN ACCOUNT**, Refinery Nagar, Mathura. This amount will be refunded without interest to unsuccessful bidder, after finalization of contract or within three months of closing date. **Maximum rate Rs 325/- only**
25. If any case the contractor violates the terms and conditions of the contract the Security Deposit will be forfeited.
26. The contractor should follow the instructions of Maintenance of Hygiene in Canteen/Kitchen as per OM No.10/1/2010-Dir dated 10-08-2010 issued by Govt. of India, ministry of Personnel, PG & Pensions, Department of Personnel & Training.
27. Portable Drinking water is to be provided by the caterers.
28. The cater should follow all guidelines as decided by UP State or Central Government of India for providing catering services
